





To collect, document and conserve evidence of Barbados' cultural, historical and environmental heritage; and to interpret and present this evidence for all of society.








The Museum and its Message



s Barbados moves with certainty and confidence towards a fiftieth year of political independence, it's Museum and Historical Society remains as faithful recorder and interpreter. This professional and objective role entrusted to the Museum is one not dissimilar to that extended to museums as a whole but it takes on a particular dynamic in the case of those national museums which function within modernising societies. In Barbados, the public education role of the Museum is therefore never overstated. For it informs not only in the fine areas of design and art in their primary senses, but also above and beyond with the messages and mission which accompany that subject matter. Naturally, our standing galleries provide answers on an ongoing basis, and no doubt such answers will vary according to the questions posed and also on how in the viewers' mind the questions are framed. Our temporary exhibitions play a similar role but because of their new and temporal quality, the message may be more circumscribed and specific. As a national institution, our role ipso facto extends further, for we are emboldened to encourage, capture and blend a wide array of persons with the objects and activities which represent Barbadian history and its contemporary culture.

During the year under review, this broad Museum mandate continued to be satisfied in the roles of our galleries, our lecture series, our Journal and our Museum Shop, and in our consulting services to Government and the private sector. As we approach our 50th year of Independence, we also look forward to a completed Walled Garden Theatre which will surely satisfy and supplement our ongoing mission in an educationally diverse manner. The Mission Statement of Art on the London Underground refers to providing a world class programme of contemporary art that enriches the Tube environment... and it succeeds. The Barbados Museum as a National Institution has also delivered on its ongoing wider mandate... albeit from above ground!

he 2013 to 2014 year promised to be a challenging and interesting one as we celebrated our 80th birthday while charting a new path towards ensuring a balanced budget and raising revenue. The period under review witnessed the opening of two temporary exhibitions: "Leviathan", exploring the history of shore whaling in Barbados and "80", the museum's anniversary exhibit that examined the history of the island in 80 objects.

Varied programming saw an increase in new audiences at the Museum programming for the year resulted in good public response for our hikes and tours. This more assertive promotion also resulted in an uptake of tables for the 80th Anniversary gala and the night of activities was well received by those who attended. The 80th Anniversary activities were well attended by the general public, Museum members and staff, beginning with the church service in early May and extending throughout the year.

The Museum hosted the inaugural Queens Jubilee Scholarship which was a collaborative project that examined "Plants as Secret Agents of Transformation in the Cultural Landscape of Barbados". It involved the recruitment of three scholars attached to the BMHS, Bellairs Research Institute and the Barbados Community College respectively. Three projects encompassing an art exhibition, monograph and living heritage exhibit are the output of the project.

While funding efforts have proven to be difficult in the prevailing economic climate, our visitor figures during the summer were bolstered by visits from summer camps that saw some 2072 students visit the Museum during the period under review. Tours were assisted by participants in our Junior Curators programme which is in its 22nd year with corporate Barbados providing some assistance with funding this year.

The 80th year has also been one of introspective and retrospective examination, where we continue to engage the public on the diverse meanings of what it is to be Barbadian, while evaluating and planning a way forward (during a time of fiscal recession), which will stimulate growth and development over the next 5 years. The Museum remains attentive to the changing cultural landscape and continues to explore new ways in which it may attract and engage new audiences and develop partnerships with other stakeholders in the delivery of cultural appreciation and content.

Museum publicity both in the traditional and non-traditional media has been extensive and in one measurable instance an increase in donated objects was attributed to the BMHS presence on the call in programme "Talk yuh Talk". Such events are aimed at, not only raising funds, but



showcasing the Museum to non-traditional museum audiences through programming activities such as a Performance Poetry evening at the Museum. We must therefore seek to continue to create programmes that further attract the local population which is our primary audience.

The Museum continues to update its collections database as well as inventory of new collections such as the Panama Registers for 1906 to 1907. We were also asked to provide artwork for the prestigious **Caribbean Crossroads** exhibition housed at the Perez Art Museum in Miami slated for March 17th 2014. This loan signals the strength of our collection as well as its international appeal. This strength is also evidenced by the Museum's continual appeal for internships as we welcomed heritage studies intern, Michael Walcott; art intern Jessica Taylor for an extended internship; as well as Teresa Shropshire, who was affiliated with the BMHS as a Research Assistant as part of a Stanford University AR grant to study the BMHS' collection of Black Portraitures.

However, internally, the renovation of the library took much longer than projected owing to the need to maintain best practice as it related to building renovation which resulted in research and documentation being curtailed on two occasions to ensure that the correct materials and techniques were being employed. The library reopened in September 2013 to the public.

As 2013 drew to a close, the Museum sought to diversify its revenue streams by exploring the development of its own branded photographic prints in addition to staging an "Old Year's Night" event.

Nevertheless, financially we have operated in an environment where we have pared back expenditure as much as we can and have turned to various sources including staff to generate ideas both for reduced expenditure and revenue generation. Revenue improved when compared with the same period for 2012 but was still below forecasted figures for 2013. We continue to operate in an environment where we must increase revenue and development funding for the Museum. However, our funding support, though on the rise, has not yet been able to keep pace with our needs. The Museum's professional resources continue to provide assistance to service a growing demand from other agencies. It is therefore important that as the New Year dawns, we seek to be nimble as we conduct our business and move to form partnerships with entities both for support and programming.

The year, though beginning with economic uncertainty, has seen continued increase in visitor arrivals over last year's corresponding period with a notable increase also in venue rentals. We are optimistic of the spread of that paradigm shift across the institution. As an institution we look forward to the new financial year with an air of optimism and expectation of growth and new opportunities. This provides an opportunity for the Museum to reposition its brand to be the premiere cultural institution of the island. It is a year in which we must be able to grasp those elements that allow the organisation to actualize its mandate as it charts its path in an unstable economic climate.

At the same time, our special events must explore partnerships with those who can provide an experience for the visitor that is both in keeping with the museum's remit and environment and attractive enough to encourage repeat visitation.

We must be prepared to adapt quickly to opportunity and realise that it is not Museum "business as usual" as is evidenced by our counterparts globally

to benefit both personnel skills and institutional practice.

Professional Development

Staff attended the following conferences/workshops during the period under review:

- "Leadership in Strategic Health Communication", hosted by The National HIV/AIDS Commission in collaboration with the John Hopkins University's Bloomberg School of Public Health – April 8th to 19th 2013.
 From April 8th to 19th 2013, the Museum's HIV/AIDS Coordinator, Curator – Allison Callender, attended a workshop entitled "Leadership in Strategic Health Communication", hosted by The National HIV/AIDS Commission in collaboration with the John Hopkins University's Bloomberg School of Public Health. The two week workshop, facilitated by Benjamin Lozare, Ph.D. and Andrea Browne, was held at the Savannah Hotel.
- Museum and Heritage Show at Olympia, London May 13th to 17th 2013


The Museums and Heritage Show brings together all of the latest technologies, services, latest thinking and ideas for anyone working in museums, galleries, heritage and cultural visitor attractions. The Curator Art/Art History who attended this event was therefore able to benefit from the comprehensive programme of free seminars together with live discussions, seminars, special features and new product launches; combining the perfect mix of hot-button topics, leading experts, inspiring case studies, real advice and solutions, around the key areas of interest including Collections Management, Audience Development, Visitor Insight, Exhibition Design & Interpretation, New Technology, Learning and Retail and Trading. Funding support was received for this trip by the British Embassy.

Consultation on Traditional Knowledge, Traditional Cultural Expressions and Genetic Resources –
 May 14th, 2013.

The Assistant Curator Natural History, the Librarian and the Education Officer attended this Consultation on May 14th, 2013 which sought to gather information about Barbadian resources on traditional knowledge, cultural expressions and genetic resources from key stakeholders. This consultation was hosted by the Department of Corporate Affairs and Intellectual Property (CAIPO) in association with the World Intellectual Property Organization (WIPO).

The consultation formed part of the research phase of the regional project aimed at "the establishment of a framework for the protection of Traditional Knowledge, Traditional Cultural Expressions and Genetic Resources in the region." This consultation, while reiterating the importance of documenting cultural heritage, also emphasised the need for a protection mechanism to ensure that the patrimony of the Caribbean is not misappropriated.

The consultation helped to underline the importance of the museum as an institution charged with the collection of aspects of our heritage and highlighted the BMHS' role as a resource for both tangible and intangible heritage. It was evident however, that more emphasis must be placed on the collection of the



intangible. An example of this type of intangible heritage was highlighted by Dr Richards who mentioned a community in Jackson, St. Michael that has traditionally harvested and eaten the fruit of the Baobab tree at Warrens.

American Alliance of Museums Annual Meeting and Museum Expo – Baltimore, Maryland – May 19th to 22nd 2013

The Alliance's Annual Meeting is the premier professional development opportunity of the museum year, as some 5,000 museum professionals gather to network, grow and learn from each other. Sessions covered such diverse topics as institutional planning, collections care and museum theatre providing many opportunities for gaining new knowledge and experience which would be of benefit to the BMHS institutional knowledge. The Curator Art/Art History presented a paper entitled "Sustainable Developments for Museums" and participated on a panel addressing the topic: "Sustainability Challenges for Museums."

International Council on Archives Conference – UWI, Cave Hill – June 26th, 2013

On June 26th, 2013, the Development Officer and the Librarian represented the Museum at the opening of the International Council on Archives Conference held at the University of the West Indies. Prof. Sir Hilary Beckles gave welcoming remarks which highlighted the importance of preserving historical documents and engaging support for such endeavours. Some of the Archives Conference participants who took the opportunity to attend the Crop Over Lecture by UWI Librarian Elizabeth Watson and view the Crop Over Exhibit Opening, which coincided with the conference.

International Council of Museum (ICOM) General Conference from 10th to 17th August, 2013 Rio de Janiero

The Curator – Art/Art History and the Assistant Curator – History, supported by a travel and accomodation grant from the International Council of Museums (ICOM) attended the above captioned conference. The Curator presented a research paper on "Folk Culture and Costumes in Barbados". This presentation was made available on the ICOM International Committee for Museums and Collections of Costume (COSTUME) website.

She also attended the Advisory meetings as Chairperson of ICOM Barbados, sat on the Elections Committee, and was interviewed as one of the many Chairpersons attending the Conference. The interview was placed on


YouTube as well as on the ICOM Rio 2013 Facebook page. In addition to attending the Advisory Council meetings, the Chairperson in her capacity as a member of the Elections Committee, was rostered to sit in the voting area, attended two days of meetings with the International Committee for Historic House Museums (DEMHIST) ICOM and International Committee for Museums and Collections of

Archaeology and History (ICMAH) ICOM respectively and part of a day with International Committee for Architecture and Museum Techniques (ICAMT) ICOM benefitting form the opportunity to interact and exchange ideas and information with international colleagues in these areas.

The Assistant Curator - History also benefited significantly as he was able to meet with a wide variety of



museums professionals from diverse institutions and was also able to participate in the international committees of ICOM – the International Committee for Historic House Museums (DEMHIST) and the International Committee for Museums and Collections of Archaeology and History (ICMAH).

World Federation of Tourist Guide Associations (WFTGA) Hands on Tourist Guiding and Train the Trainers – September 2013 – Ocho Rios, Jamaica

On September 3rd, 2013 the Education Officer participated in a Caribbean Tourism Organisation (CTO) – developed train-the-trainer workshop for tour guides. The workshop was coordinated by the CTO and facilitated by the HEART Trust/National Training Agency, with funding support from the Caribbean Development Bank (CDB)/Basic Needs Trust Fund (BNTF).

The objectives of the training programme included developing an understanding of the purpose and use of competency standards for tour guides within a national and regional vocational qualification framework; completing a review and familiarity exercise with the curriculum, especially as it relates to the practical side of the training covered in the curriculum; and ensuring that the assessment procedures were understood and could be put into practice across the region.

Although it was targeted to tour guides, the principles of the sessions were all based on general educational theory and could be used to for general training across subjects. This workshop was attended by tour guides from across the region including Belize, St Vincent, Grenada, Trinidad and Jamaica.

Commonwealth Association of Museums (CAM) Disaster Risk Management for Caribbean Museums Workshop, Bahamas, September 24th to 27th, 2013


This workshop fully funded by the Commonwealth Association of Museums (CAM), was convened to examine issues pertinent to Risk Management particular to Caribbean Museum facilities including identifying and mitigating risks; first aid for heritage buildings and artefacts; and discussion of whether there is a need for a regional response network to deal with common issues. The Curator – Art/Art History presented papers entitled "Disaster Risk Reduction and General Emergency Preparedness" and "Resources Available in times of Disasters", and also sat on the panels of two panel discussions related to risks and disasters. She also benefitted from exposure via visits to local heritage sites, museums and the national gallery whilst on location in the Bahamas.

• John Carter Brown Library Conference 'Beyond Sweetness'- October 24th to 27th, 2013

The Assistant Curator – History attended this conference hosted by the John Carter Brown Library, Brown University, Providence, Rhode Island. The conference titled 'Beyond Sweetness: The New Histories of Sugar in the New World' explored numerous themes related to the sugar and its heritage inclusive of the Archive of Sugar, Experimentation and Technology, Landscape and Labour and Legacies. He presented a paper titled "Refining Sugar: The Re-representation of Sugar as Barbadian Heritage by the Barbadian Museum and Historical Society". The paper was presented in the session which discussed the legacies of sugar. The paper was well received; however the Assistant Curator – History was one of only two museum professionals who attended the conference. The Assistant Curator received a travel and accommodation grant to attend the conference courtesy, the John Carter Brown Library.

"Exploring Transatlantic Archives through Place and Time" – November 21st to 22nd, 2013

The Librarian attended this two-day workshop which was hosted by the University of West Indies and facilitated by LEARN NC based at the University of North Carolina, Chapel Hill, the National Archives (UK), and the Virginia Geographic Alliance. Participants were given insight into how geospatial software such as Google Earth, GPS



units, ArcGIS, and sites such as HistoryPIN could be used to better research and display archival resources.

Small Grants Workshop – November 25th 2013 – US Embassy

On November 25th 2013, the Development Officer joined the Deputy Director in attendance at a full-day US Embassy workshop focused on assisting non-profits and other entities with navigating the US Government's small grants program administered by the Embassy, and providing tips to strengthen request for funding applications. This workshop provided a wealth of information which will be used to guide the Society in preparation of its funding proposals through that entity going forward

Producer's Checklist Workshop – March 2014

The Marketing Officer and Administrative Officer – Marketing and Events attended a Producer's Checklist Workshop held by the National Cultural Foundation at Bagnall's Point Gallery in Pelican Village. The workshop which took place over 3 weekends from March 15th to 29th 2014 was designed to assist individuals/organizations in developing concept documents in line with NCF requirements. The workshop was divided into three sections, "Event Concept", "Permits & Licenses" and "Marketing, Public Relations and Sponsorships". Outcomes from the workshop included creating a concept document, in class presentations, and finally a pitch at the NCF headquarters.

In House Training

Object Handling Workshop

The Curator – Art/Art History facilitated an Object Handling workshop for new staff members, as well as a refreshers course for other staff members during May 2013. This was done in preparation for the 2013 hurricane preparedness exercise.

Communications & Customer Service Refresher

On July 3rd 2013, all staff attended an in-house Communications and Customer Service refresher presentation by the Marketing Officer designed to enhance staff skills in these areas.

Consumer Protection Workshop


On November 20th 2013, BMHS Staff members attended an onsite workshop facilitated by the Fair Trading Commission on consumer protection. This informative workshop highlighted potential gaps in the BMHS customer service strategies which were subsequently addressed.

Fire Extinguisher Utilisation Training

During the month of March 2014, the BMHS staff was given a refresher course in the use and types of fire extinguishers by the Barbados Fire Service. After a PowerPoint overview session in Temporary Exhibition Gallery 1, a practical session was conducted in the Walled Garden where each participant was required to extinguish a fire demonstrating appropriate use of an extinguisher.

HIV/AIDS Awareness Programmes

A "Health and Wellness Day" for the staff and members of the community was held on the museum grounds on June 27th 2013. WIBISCO, Armstrong Agencies, Facey Trading and 6's Sunrise Inc. were amongst some of the companies who offered their products and services for the event. The Diabetes Association of Barbados provided



blood pressure, blood sugar and cholesterol testing on the day and the Ministry of Health conducted a lecture on safe sexual practices; whilst a representative from TTTR (These are the True Remedies) gave a lecture on Diabetes.

In support of other coordinators' projects and activities, the coordinator and Assistant Curator for Natural History attended the production "Images of Hope: 10 years of involvement in the National Aids Program", hosted by the Ministry of Tourism and International Transport on October 24th 2013.

ICOM Barbados Membership and Participation

At the first ICOM General Meeting held on January 16th 2014, three members of staff were voted to serve on the Executive Committee of The International Council for Museums (ICOM) Barbados from 2014-2016,

The Curator Art/Art History and the Assistant Curator Natural History co-wrote an article entitled "Are you Connected", which was published in the ICOM News December 2013 edition. The article was a follow up to the proposal for the 2014 International Museum Day Theme "Museum Collections Make Connections" which also proposed by ICOM Barbados through this collaborative pair from the BMHS and accepted worldwide by ICOM International. 



Figure 2 - "What's your Connection" Article in ICOM News

To Ensure Implementation of a Rolling 3-Year Commercial and Marketing Plan

- Used non-traditional media sources to reach newer audiences for museum programmes and activities

80th Anniversary Features – Barbados Advocate, Daily Nation & Barbados Today






Figure 3 – BMHS Scarlet Gala Celebration





Figure 5 - Cover Art - 80th Anniversary Edition - BMHS Journal Volume LIX December 2013




Figure 6 - Cover Art - Barbados Panama Connection Revisited




Figure 7 - Cover Art - Plantation to Nation: Caribbean Museums and National Identity



Plantation to Nation

Following a successful launch in Jamaica, Plantation to Nation: Caribbean Museums and National launched Identity was Wednesday, 19th March, 2014 at the Barbados Museum and Historical Society, the first book devoted to the history and development of Caribbean Museums. The launch was well attended by over 40 persons, including academics from the University of the West Indies (UWI).

Co-authors of the text, Hilde Neus from Suriname and Dr Edward Harris from Bermuda, provided some comments and presentations of the text were made to repre-



sentatives from the Sidney Martin Library, the National Library Service and the Shilstone Memorial Library. BMHS President, Sir Trevor Carmichael delivered the featured address which highlighted the importance and relevant timing of the text as it 'recognises the birth of Caribbean museums from colonial era institutions which were faithful adjuncts to the status quo to the present day institutions...'

The event was also attended by prominent historians Sir Woodville Marshall, Professor Henry Fraser, Dr. Karl Watson, Dr. Lennox Honychurch and Dr. Marcia Burrowes.

A copy of the press release was also featured on the BMHS website, and media coverage for the launch included a full page in the *Barbados Advocate* newspaper dated Sunday, 26th March, 2014.

The Director and Deputy Director made presentations of the 2013 Journal, a reprint of the 1933 Journal and a copy of the Plantation to Nation text to the Minister of Culture, Sports and Youth, the Hon. Stephen Lashley. The event was well attended by the press who were given an opportunity to ask questions.






Figure 11 - Launch of BMHS Lecture Series






Figure 14 – Patrick Foster Performing at the BMHS




Figure 16 - Promotional Flyer - Eighty

STRATEGIC PLAN: CHARTER 3

To Develop a Museum and Heritage Aquisistion Plan, Improve its Inventory Management and Tracking Systems and Enhance Conservation of its Collections.

The BMHS has achieved the following targets:

- Assignment of 240 accession numbers to new objects added to the BMHS collections
- Updated the collections database with an additional 414 objects
- Added 182 book titles to the PastPerfect database

Collections Management

The BMHS continued to grow with the inclusion of another four hundred and fourteen (414) objects into the collections database. These included objects from the Decorative and Fine Art, Toy and Photographic collections. In addition to this during the months from December 2013 – February 2014 the Assistant Curator for History inventoried, photographed and entered into the BMHS Past Perfect database a total of eighty-eight (88) objects from the Egyptian Collection.

Also during this period, the Registrar and Assistant Curator – History organised documentation of ninety (90) postcards and Photographs from the Photographic collection, with the assistance of Docents in preparation for data-entry into the Museum's collection database.

Three junior curators assisted the Curator Art/ Art History with inventorying and cataloguing the toy collection, for the proposed refurbished Children's Gallery. Also during the period in question the Assistant Curator – History assigned the task of inventorying the remainder of the Gabriella Moenig World Music Collection to the Junior Curators.

The Assistant Curator – History was assisted by Janice Gittens and Margaret Daniel in the digitization of the Panama Names Database lists the names of 6,000 men who migrated to work on the construction of the Panama Canal in 1906 – 07.

Art History student Jessica Taylor commenced a six month internship with the Curator Art/Art History in January 2014, which concluded during August 2014. While at the BMHS, Jessica worked closely with the curator assisting with the inventory of the BGA collection, updating the fine art collection as well as categorizing its inventory, research and images for insertion into the database, and creating several documents based on research obtained from the BMHS journals, catalogue cards and other sources, such as the Shilstone notebooks.

Ms. Teresa Shropshire, also joined the BMHS as a part time research assistant working on a mini exhibition on black portraits of both enslaved and freed individuals. The exhibition was largely aimed at documenting recent acquisitions of the Museum, in terms of providing contextual information in labels/brochure/mini catalogue.

Books

One hundred and eighty-two (182) books/pamphlets were catalogued and added to the Past Perfect database.

Newspapers

Volunteers continued to reduce the backlog of newspapers. One volunteer, Margot Frost, also clipped the digital newspaper, Barbados Today from her home.



Bookcases

The reinstatement of the library provided an opportunity to conduct general house-keeping on these cases. To that end, volunteer Elma Licorish has been assigned the task of organising and listing the contents of selected cases. To date listings have been produced for Case 1 and for the Chapman Notebooks.

Collections Development

Gifts and Acquisitions

The Curatorial Department completed the registration of two hundred and seventy-three (273) objects through purchases and donations into the Museum Social History, Natural History and photographic collections. These items included two (2) 1955 sculptures by Karl Broodhagen along with a collection of photographs, postcards, records and artwork from the late William Bertalan's collection.

Some of the items donated to the Museum by members of the public also came as a result of the participation of the Deputy Director and the Curatorial staff members who were guests on the "Looking Back" programme on CBC radio.

Notably, on July 22nd 2013, the Registrar, Curator for Art and Art History and the Assistant Curator for Natural History visited Colleton House to collect three (3) portrait paintings which were purchased by the Barbados Museum.

In September 2013 the Assistant Curator – History received on behalf of the BMHS several costumes from Ms. Audene Holder, used as educational tools for children to inform them as to how fashion has evolved in Barbados. Ms. Holder also donated models of toy trucks and a slave hut to the BMHS.

In February 2014 the Curatories received for the collection, several photographs of and by the late American sculptor and war photographer, Mr. William Bertalan.

On March 24th 2014, the curatorial department and intern Jessica Taylor, under the supervision of the Director, were invited to the home of the late artist Mr. Maurice Drakes in order to conduct a complete inventory of his works. This was initiated in preparation for the removal of the collection to the BMHS for safekeeping. Jessica and the Assistant Curator – Natural History assisted with photographing the objects in situ.

During the month of March, the Assistant Curator Natural History, along with the Curator Art/Art History visited Ragged Point after receiving information that a sperm whale carcass had washed ashore. The curators


Figure 19 – Intern Jessica Taylor taking photos in-situ of the Collection of the late artist Maurice Drakes

descended the Cliffside to the sheltered bay where the remains were found, however the state of decomposition of the carcass did not permit its recovery.

In addition, forty-five (45) new items, consisting of thirty-four (34) donations and (11) eleven purchases, were added to the Shilstone Memorial Library's collections.



Outgoing Loans

On May 31st 2013 the Registrar facilitated the release of six (6) paintings from the Barbados Gallery of Art Collection housed in the Museum's Holetown space. These paintings were loaned by the BGA to the Ministry of Culture, Sports and Youth for display during the Heritage Month exhibition which was opened in June 2013.

The Registrar also organized the insurance and loan of the BMHS' Barbados 1788 Pineapple penny to the Central Bank of Barbados. The penny was shipped to Iron Age Design in the U.S.A. on July 24th 2013 in order for a mold to be made from the coin.

The BMHS also loaned a painting entitled "Cane Fire" by Artist Leslie Lounsbury to the Perez Art Museum Miami, from the Museum Fine Art Collection. This painting will be on loan to the Museum from March 17th 2014, for the Caribbean Crossroads of the World Exhibition. Caribbean: Crossroads of the World highlights over two centuries of rarely seen works – from paintings and sculptures to prints, photographs, instal-lations, films, and videos – dating from the Haitian Revolution to the present.

This exhibition employs an inter-disciplinary approach to advance our understanding of the Caribbean and its artistic heritage and contemporary practices. It focuses on four central themes: Fluid Motions, Counterpoints, Shades of History, and Kingdoms of this World. These interconnected frameworks allow insight into the complex context from which the vital and varied artistic production of the region has emerged, illuminating the multiple histories of the region.

Reproduction Requests

The Barbados Museum continues to service the needs of the public from its image collections. During the period under review twenty-five (25) reproduction requests utilising seventy-nine (79) images from the photographic collection were approved. These images were used for display purposes, overseas film groups, publications, and Independence celebration displays for primary schools and also for presentations for the 2013 BMHS lecture series.

In addition to this, the Curator for Art/Art History and the Registrar assisted Ms. Sarah Thomas from the Tate Gallery in the U.K, with research into the Museum's Fine Art Collection focusing on works depicting art and the empire. The 105 images that were selected were used for research purposes and also for an art presentation for students visiting the Tate Gallery.

The Registrar, Deputy Director and the Marketing Officer to select and prepare a list of photographs and images from the BMHS Photographic collection, pre-approved for persons seeking to reproduce these images from the Museum's collection, for publications and also for the General Post Office 100th Anniversary of the Panama Canal commemorative stamp series.

Consultations with Queen's Jubilee Scholars

Under the guidance of the BMHS Council President, Sir Trevor Carmichael, Ms. Susan Mahon, Director of the Bellairs Institute of McGill University, the Director, Deputy Director, Curator Art/Art History and Assistant Curator Natural History met with the Queen's Jubilee Scholars to assist with the realization of a Living Heritage Exhibition called, "Plants as Secret Agents of Transformation in the Cultural Landscape of Barbados", at Bellairs Research Centre, Holetown, St. James on Friday July 18th 2013.

The meeting took the form of an interactive workshop and participants came up with a list of plants significant to the Barbadian landscape, along with a number of themes that should be explored for the exhibit.

To Acquire Financial and In Kind Support for each Operational Project, Event, Programme of Initiatives undertaken by the Museum.





Figure 21 – New Membership by Category April 2013 to March 2014








Figure 22 - Elio Villafranca Jazz Event Flyer




Figure 23 – Temporary Stage Erected for World Theatre Day Activities in the Walled Garden 80th Anniversary Scarlet Gala – Harewood & Jubilee Galleries Fundraiser





Figure 24 – 80th Anniversary Gala Flyer


In-kind Support

STRATEGIC PLAN: CHARTER 5



To Plan, Organise, Coordinate and Evaluate Educational Programmes and Exhibits Geared Towards Young People.

The BMHS has achieved the following targets:

- The successful staging of the third Basic Genealogy Workshop on November 2nd, 2013.
- Continued collaboration with the Barbados Department of Archives for completion of a successful Basic Genealogy Workshop.
- The planning and launch of the BMHS/BDA Genealogy Group on March 20th, 2014.
- Training of four (4) volunteers to facilitate extended opening hours for the Library.
- Initialization of a database project to record Barbadians who migrated to Panama during the period 1906 to 1907.

Overview

The depressed state of the economy has had its effect on the entire institution and in the Education Department, one of the ways it has manifested itself is in low numbers of visitors from the schools. The number of visitors totalled 5,634, and this included a total of 2,895 in the summer months of July and August when summer camps and other community groups visited in large numbers. This indicated that actual school visits were only at 2,739.

Schools Outreach

Some of the schools which were visited include during the course of the year included Arthur Smith Primary, the Bay Primary, St Paul's Primary, St. Ambrose Primary, George Lamming, St Giles Primary, Wesley Hall Primary and Belmont Primary. Some of these schools also participated in the annual Kites Workshop which was planned by the Education Officer and the Assistant Curator – History. The workshop was facilitated by Addington Forde and has been designed to increase the number of young people who are able to make traditional Barbadian Kites.

On June 13th 2013 the Education Officer attended the speech day and graduation ceremony of the Wesley Hall Infant School which was held at the Lloyd Erskine Sandiford Centre. At this ceremony the Principal, Mrs Sylvia Scantlebury highlighted the Museum's Education programmes.


On June 27th 2013, the Education Officer gave the feature address at the graduation ceremony of the St Matthew's Primary School. Since the theme was "Guardians of our Heritage, Craftsmen of our Destiny" the officer took the opportunity to discuss our World Heritage status and show how we can be guardians of the rich heritage we possess all over the island.

Teacher's Professional Day

There was a high concentration of teachers at the Museum October 18th 2014, Teacher's Professional Day. The Arthur Smith Primary were hosted for the whole day by the Museum. Concepts of Africa and Visual Literacy were the topics for the day, followed by a heritage tour. Arrangements were also made for island Heritage Tours for 4 other schools – Blackman-Gollop Primary, Westbury Primary, St Mary's Primary and Grantley Prescod Primary. Sites visited included the Garrison Historic area, South Point lighthouse, Newton Burial Ground, and East Point Lighthouse

Junior Curators

Much of June was taken with training of the Junior Curators in preparation for their 8 week summer programme. Training sessions included an overview of the Historic Garrison area so that they could rise to this challenge if any



group required this tour. The JCs started their work on July 8th 2013, immediately following the end of the school year.

As part of their continued training they were taken on a tour to The Olympic Museum, Gun Hill, Hackleton's Cliff, Bathsheba and to Highland Pottery in Chalky Mount. By the end of July they had completed tours with over 1600 visitors and were assisting the curatorial staff with a variety of assignments.

The Junior Curators programme continued until August 29th when it ended with a presentation of the Junior Curators to representatives of the organizations which partially sponsored the programme. The press was invited to the event and much coverage was given in the printed media in the following days.

Exhibitions

80: Celebrating our History, Our Heritage, Our People

To commemorate the 80th Anniversary of the Barbados Museum & Historical Society, the Curatorial Department was charged with the task of developing a temporary exhibition that would not only celebrate the institution and it stakeholders but also Barbados' History

and Heritage during the 80 year period. To achieve this end, the Curatorial Department led by the Deputy Director, commenced a series of rigorous 'brain storming' secessions to develop themes and concepts that would achieve the outlined goal. After numerous meetings it was conceptualized that the 80th anniversary exhibition would attempt to tell the history of the Barbadian civilization with 80 artefacts held within the Museums' permanent collection. Further, it was decided, that in order to present a balanced narrative that artefacts from all four overarching collections would be used: Natural History, Fine Art, Social History and the Archaeology collection.

Additionally, the notion to make the exhibition as accessible to the public was embraced by the Curatorial Department and it was decided that the exhibition would also exist in virtual space with its own web link on the BMHS'



web page. Finally it was also decided that due to wide use of mobile devices inclusive of cell phones and tablets that each artefact label would have its own QR code. This would allow patrons of the exhibition to scan the codes with their phones to access more information about the artefacts on display.

To reach the Museum's public, it was decided that during the week of the installation of the exhibition that the BMHS stage an event titled 'Behind The Scenes' where the public would be invited to tour the galleries of the BMHS and view the 80th Anniversary exhibition being installed. This activity allowed the public the opportunity to interact with Curators and ask questions about the exhibition, the artefacts being presented and pose general questions about curatorship. The exhibition was successfully opened to the public on the 31st May 2013 to coincide with the BMHS' 80th Anniversary Gala event and guests at the Gala were treated to special guided tours of the exhibition space.

Leviathan: A Story of Shore Whaling in Barbados

The Assistant Curator Natural History mounted the whaling exhibition scheduled for April 15th to September 15th, 2013. This included painting the walls in the temporary exhibition gallery, mounting of a whale skeleton on loan from Folkestone Marine Reserve and Park, mounting text panels and the redevelopment of the "Food from the Sea Case" in the Harwood Gallery with the assistance of intern, Michael Walcott. The exhibition was opened on April 14th, 2013 with Dr. Lorna Inniss, Acting CEO of the Coastal Zone Management Unit, as the featured speaker and was well attended.

Some Ting in de Music: The Story of Calypso in Barbados

In 2013, the BMHS hosted its exhibition titled 'Some Ting in de Music: The Story of Calypso in Barbados' explored the evolution of Calypso as a musical genre in Barbados. The exhibition examined themes such as the origins of Barbadian folk music tradition in the immediate post Emancipation

dispensation, the structure of traditional Barbadian folk music, the transition to Calypso in the 1920s, influences to genre in throughout the 1950s, 1960s and 1970s.

Additionally the exhibition featured a documentary that highlighted several of Barbados leading calypso icons including Emile Straker, Anthony 'Gabby' Carter and Don Marshall (Sir Don). The opening of the exhibition was preceded by a lecture delivered by Ms. Elizabeth Watson titled "A Queen and Her Court" which examined the role of women in calypso in Barbados.




Figure 28 – One of the displays at the "Something in de Music: The Journey of Calypso in Barbados" exhibition





Figure 29 – Promotional Flyer "Something in de Music: The Journey of Calypso in Barbados"

Kite Making Workshop 2014

In February the Assistant Curator – History along with the Education Officer completed plans for the second annual BMHS Kite making workshop titled 'Go Fly a Kite Two'. In preparation, the Education Officer visited several schools in the St Michael area informing them of, and soliciting support for, the upcoming Kites Workshop.

The Kites Workshop was attended by nineteen (19) students from 4 of the schools. In addition to three of the primary schools, one secondary school participated. The schools which participated were:

- The Arthur Smith Primary
- The Bay Primary
- Belmont Primary
- The Graydon Sealy Secondary

By the end of the three half-day sessions, students had learnt how to fit the 'bones' together, how to string the kite, how to cut and paste the paper and make a 'mad bull', as well as how to loop and tail the kite. A 25 minute presentation from the Barbados Light and Power Co. about safe kite flying ensured that participants knew the dangers involved in kite flying and the safety rules.

The workshop was aimed at children ages 8-13 and was designed to teach that particular demographic of school children how to make traditional Barbadian kites. The workshop was tutored by Mr. Addington G. Forde, master kite maker and author of the book 'Kites'.

Whaling Movie Evenings

The Assistant Curator – Natural History, as programming activity in support of the "Leviathan" exhibit, executed a 3 part movie night series of the BBC films Ocean Giants. These films ran for approximately 1 – 1½ hours on the lawn of the Lower Courtyard on May 3rd, 10th and 17th 2013 respectively.





Figure 31 – Flyer for Ocean Giants Movie Nights at the BMHS May 2013



Despite the threat of rain on the latter two nights, each film night saw approximately 40 – 50 persons in attendance each night. Adults were charged \$10.00 admission, whilst children were charged \$5.00. Freshly popped popcorn and soft drinks were available for sale and the proceeds were used to offset the cost of the licensing of the films for local viewing.

Turtle Walks

On June 22nd and July 27th 2013, the Barbados Museum held its annual Turtle Walks in collaboration with the Barbados Sea Turtle Project (BSTP). Walkers met at the gazebo on the Richard Haynes boardwalk and were introduced to representatives from the BSTP before beginning their walk. The programme, in its 4th year, seeks to expose members of the public to the nesting habits of the Hawksbill turtle and also to the conservation efforts being taken in Barbados to conserve this endangered species.

Museum Hikes & Tours

Chancery Lane

On February 1st 2014, the Assistant Curator Natural History led the Chancery Lane walk for the first hike scheduled to commemorate World Wetlands Day which is observed on February 2nd annually. This walk was attended by approximately 20 persons.

Heritage Tours

In November 2013, the Assistant Curator History designed and conducted a special tour of the World Heritage Property. The tour commenced at the BMHS, visited the National Armory, proceeded to Bridgetown and visited the National Heroes Galley and Museum of Parliament and the Nidhe Israel Museum and Synagogue. The tour was created for ICOM Barbados.


In December of 2013, the Assistant Curator History conducted a walking tour of the Historic Garrison with Dr. Karl Watson and Mr. Peter Stevens of the Garrison Consortium. The tour was conducted on behalf of the Ministry of Culture, Sports and Youth and was designed to familiarize Barbadians and visitors of the history and heritage of the Garrison Historic Area.

University of Washington

A general tour of the Museum was given on Monday July 1st, 2013 for twenty [20] students from the University of Washington who visited Barbados to undertake a course in Communication Culture for three weeks. The students visited several museums and heritage sites whilst attending lectures and events relating to Barbadian culture.

BMHS History Group

Mr. Matthew Reilly, a PhD candidate in the department of anthropology at Syracuse University, presented a paper entitled "The School of Female Industry: Race, Class, and Gender in Colonial Barbados" which detailed the existence



of a school which catered to poor white girls in the late eighteenth century, on the 28th May 2013 at the BMHS.

In July a lecture entitled 'Archaeology of an Emerging Landscape of Power and Enslavement in early 17th Century Barbados' was presented by Professor Douglas Armstrong, also of Syracuse University, and was well attended by members and nonmembers of the society alike.

October's talk was given by Mr. Sabir Nakhuda on the 100 year history of Indian migration to Barbados and was based on his




Figure 33 – Sabir Nakhuda – Author of Bengal to Barbados: A 100 year history of East Indians in Barbados




Figure 34 – Sabir Nakhuda Delivering the October History Group Talk

book "Bengal to Barbados: A 100 year history of East Indians in Barbados".

The first talk of 2014 to the BMHS History Group was presented by Mr. Terry Applewaite on the January 29th 2014 who discussed 'Public Health in Yesteryear Barbados: Medical Challenges and Harsh Realities for Afro-Barbadians'. He was followed on February 19th 2014 by Mr. Nathan Holder who spoke on the subject of the Tuk Band and Barbados.

The Assistant Curator – History along with the Librarian, were charged with the task of organizing a thanksgiving church service for the BMHS to commemorate the occasion of the organization's 80th Anniversary. This assignment executed in collaboration with Head of Departments and staff involved preparation and distribution of invitations to non-members, preparation of a BMHS blurb with input from Management and liaising with the church on logistical issues. The service, which was hosted by St. Matthias Church, was held on Sunday, May 26th 2013 and was well attended by both BMHS members and staff.





Figure 36 – The Director of the BMHS, Alisandra Cummins, addressing the congregation at the 80th Anniversary Thanksgiving Service

The Assistant Curator History, Marketing Officer and Director were all guests on the radio show 'Talk yuh Talk' hosted by Mark Williams of the Caribbean Broadcasting Corporation. The aim of the programme was to inform the public about the events surrounding the 80th Anniversary celebrations. The radio programme was very successful generating no less than a dozen callers many of whom engaged the museum contingent in discussion about the history and use of several artifacts in their own personal collections.

International Museums Day 2013

As part of the activities to celebrate International Museums Day, the BMHS held an open day on May 18th 2013. One of the key activities was a Garrison walk. The walk, which started at the BMHS, included some of the more notable sites of the Garrison. Commencing at 7:00 a.m., it was attended by approximately 40 people and was successful as it raised donations. The Assistant Curator History was assisted in the tour by intern Mr. Michael Walcott, an M.A. Heritage Studies student from the University of the West Indies.

The BMHS lower courtyard was also home for the day to a number of vendors who set up stalls selling local plants, jewelry, popcorn, confectionery and pudding and souse. The museum also set up a booth selling books from the Library, as well as giving information about the museum's activities including volunteering and membership. The personnel in the booth answered general questions about the BMHS, its exhibitions and upcoming programmes and ICOM Barbados.




Figure 37 - Tai Chi session at the International Museum Open Day 2013




Figure 39 – Web Invitation to the World Heritage Lecture - "Historic Core Cities: Lessons for Contemporary Sustainability"





Genealogy Workshop

The Basic Genealogy Workshop was held on November 2nd, 2013 in collaboration with the Barbados Department of Archives. Attended by thirteen paid participants, the one-day workshop was well received. The day was divided into five sessions with presentations from Dr Patricia Stafford, Harriet Pierce, Stacia Adams of the Barbados Department of Archives and case studies by Carole Bishop and Judith Toppin. During the fifth session, which was organised as a clinic, participants interacted with the presenters and toured the library. During this session, family researcher Sandra Taitt-Eaddy also shared her experience with the participants.

Although registrants were less than the previous two workshops, the event was self-sufficient and in fact recorded a surplus. The shop also sold twelve copies of the course text *Tracing Ancestors in Barbados* by Geraldine Lane. It is envisaged that the workshop will become an annual event held on the last Saturday in September.










Figure 41 – Genealogy Workshop Group

- Established an Online Content Committee to manage the development of the Museum's online branding and ensure cohesiveness in the content filtered to the public through these media.

BMHS Website

During August of 2013, a comprehensive review was undertaken of the BMHS website in order to identify areas where it could be improved in order to increase its relevancy and effectiveness in interacting with the BMHS' audiences. Several key areas have been identified for further update and development.

The BMHS website still requires significant work in order to operate at the level that is required. However, starting in December 2013 the following updates were made to the website to bring its information up-to-date and the process of updating the site with current Museum activities is ongoing:

- Our Team new employees have been added and titles changed as required
- Events All BMHS events, exhibitions and programmess have been added for 2014
- Press releases have been updated under the 'News' Section

The Marketing Officer is currently exploring options to have an e-commerce option available on the current BMHS website. In addition to the E-commerce option, we have also reached out to third party websites such as bigcartel.com about supplying us with a white label e-commerce platform and are currently awaiting feedback


BMHS Social Media

Following a review in August of 2013 the BMHS created a number of online features geared toward engaging with and maintaining the interest of the general public in the BMHS and its resources and offerings. These included a "This Day in History" article which became quite popular with viewers, the marking of significant memorial days in the calendar highlighting their significance. and highlighting museum product offerings and events. The Museum shop in particular was able to note an increase in interest in product stock which was highlighted on this platform and many positive reviews were received from the Facebook community as the membership to the BMHS' page and group increased exponentially.

Online Content Committee

In an effort to capitalize on gains made due to closer management of the BMHS website and Facebook facilities a committee was convened in September 2013 of a team of staff members representing the Museum's various departments. This committee is in the process of defining a comprehensive online strategy and protocols for management of these resources on an ongoing basis as well as making recommendations and preparation for an overhaul of the BMHS online resources.

Research

During the period under review, the Curator for Art/Art History facilitated Mr. Clish Gittens a BA student in Creative Arts at the University of the West Indies, with information on Art Managers for his course entitled "Internships".

BMHS Membership Database

In order to incorporate the BMHS databases into our main database programme such as PastPerfect, which is presently being used for the Library holdings and for the Museum's collections, it was decided to convert the BMHS Membership database which is presently in an Access programme into the PastPerfect database. In order to complete this process the Registrar worked with the Development Assistant and in consultation with the Technician at the PastPerfect software company in order to proceed with the conversion process. This process has now been completed.


Professional Services

Banks Holdings Limited

Banks Holdings Limited has extended its contractual arrangement with the BMHS for another year and as part of the Cataloguing and Digitization Project, The Registrar and Curator for Art and Art History met with Emelda Browne who is the BMHS representative for the project on November 19th 2013. This meeting was held in order to view the objects from the Banks Holdings Limited collection based on the list provided in order to ascertain the correct storage materials for the objects.

Commission for Pan African Affairs – Social, Identity-Renewal and Integrated Upliftment Strategy (SIRIUS) Project

The Education Officer, along with the Director, Deputy Director and Administration staff planned, reviewed and submitted modules to be utilised in the teaching of tour guiding training which forms part of the SIRIUS project with the Commission for Pan African Affairs. The BMHS then agreed to take on the management and execution of this training which includes components relating to History and the relevance of the World Heritage Accreditation. The BMHS therefore developed and facilitated the tour guide training component of the Social, Identity-Renewal and Integrated Upliftment Strategy (SIRIUS) Project for the Commission for Pan-African Affairs (CPAA) in October 2014. The modules and the tour guiding training session were part of a collaborative project between the BMHS and the CPAA. The training programme ran from October 2013 to December 2014.




Figure 42 - Promotional Flyer - Historic Garrison Walking Tour & Breakfast

Foursquare Folk Museum

The Curator – Art/Art History carried out repairs to the mannequin heads at the Foursquare Folk Museum during January 2014 and completed repairs to the feet and other body parts in need of repair during February with the assistance of the support staff. These repairs were in preparation for an Open Day which was held at Foursquare Rum Distillery and Heritage Park in mid-February.

On Sunday December 15th 2013, the Assistant Curator, – History conducted a walking tour of the Garrison Historic area. The Walking tour was conceived as a dry run for a heritage tourism product being jointly developed by the BMHS, the National Cultural Foundation, the Ministry of Culture, Sports and Youth and the Hilton Barbados. The tour started at the Main Guard and Clock Tower and finished at the Hilton Hotel. The tour was adjudged a success and the project was subsequently confirmed and marketed, facilitated by guides provided by the BMHS.

Golden Grove

At the beginning of March, the Assistant Curator History installed a Archaeology Exhibition **BMHS** entitled 'An Amerindian Life' at Golden Grove Plantation House in St. Philip. The installation was part of a collaborative event between the BMHS and Golden Grove to take the BMHS beyond the walls of the physical plant and into Barbadian communities. On March 9th 2014, the Curatorial Department assisted at a fundraiser held on the grounds and guiding persons to view the exhibit.




Figure 43 – Golden Grove Exhibit




Figure 44 – The Curator – Art/Art History placing an adhesive onto one of the three mannequin heads which were repaired at the Foursquare Folk Museum






Figure 45 – Curator Art/ Art History – Allison


Attendance at the World Commission on Protected Areas Meeting

National Art Gallery




Barbados Gallery of Art


Shilstone Library Renovation

A survey was conducted to provide information about the factors that had influenced indoor air quality at the museum including the library: these factors were heating, ventilation and air conditioning systems, possible pollutant pathways, possible contaminant sources and their effects on the occupants. The Main Library area was assessed to be affected by high and fluctuating humidity. The humidity in the library should ideally be maintained between 40% and 55% (installation of a dehumidifier is required to facilitate this process). The mould odour in the Library was as a result of moisture in the walls and the high humidity. The outer walls required sealing or repointing to avoid moisture leaking back into the inside walls. This moisture contributed to the flaking of paint and resultant mould growth. Gutters and roof drains required cleaning and fixing where necessary to ensure that rainwater was shed away from the building. The walls in the Library had to be thoroughly cleaned or cleared to remove any mould growth.

The process started with clearing the library to facilitate the required renovation work. A BMHS project team was formed to plan the process consisting of the Librarian, the maintenance team and the Finance Officer. The temporary gallery under the library was allocated for storage. However, an air-conditioned container was used later in the process as the gallery had to be cleared to accommodate the planned Cropover exhibition – "Something in the Music" which started on the 28th June 2013. (It must be mentioned that The Barbados Defense Force generously facilitated us by giving up the container which they were using at the time). This moving process took over two weeks and included building shelves and racks and creating a temporary storage system that would still allow for easy access to facilitate any research that would still have had to be accommodated. After completing the temporary relocation of the library the construction process was started.

This restoration phase started with the scraping of the walls to remove the damaged surface. The BMHS had to seek the input of professional conservators in order to come up with the right mix of mortar to complete the process. In the end a mix of fine coral dust, white lime and white cement was utilised. This construction process was challenging to all involved as it was not the usual type of work that would be encountered. The materials were expensive and difficult to work with and created a lot of dust but work eventually progressed beyond the re-plastering of the inner walls and repointing of the outside walls. Painting of the walls was completed using a special paint called Corical which is designed for coral surfaces. Corical paint allows the walls to breathe as it is thinner than normal paint. At the same time the BMHS took the oppor-tunity to improve the wiring of the library by installing additional electrical and data points to accommodate the increasing use of technology such as is re-quired in the digitisation process.

The construction unfortunately resulted in the finish on the floors being damaged and they had to be sanded and



re-varnished.

The Library was reopened on September 2nd, 2013, after a 9-month closure for renovations during the period December 2012 – August 2013. To mark the occasion, a cocktail reception was organised to bring stake-holders up to date on the renovations and plans for the future.

BMHS Electrical & Security Upgrade

The BMHS engaged the assistance of the Barbados Light & Power Company Limited to analyse the flow of energy at the compound and the related electrical infrastructure that was required to support safe delivery of this capacity at the facility. That exercise highlighted the following:

- The utilisation of electricity in the Museum by appliance
- That the supply of electricity from the pole to the main breaker was problematic
- That the main breaker needed to be replaced

The Barbados Light & Power

Company Limited completed an upgrade in the entire Garrison area installing an additional power supply nearer to the Museum and replacing the old wiring from the pole to the main breaker. The BMHS also changed out its main breaker and rewired the compound to facilitate this process. This process had the added benefit of eliminating some occasional power outages and brownouts to which the museum had been previously subject.


24 closed circuit cameras were installed to monitor all the galleries, the shop, and all of the entrances to the building. This installation is expected to ensure additional protection and security of the object son display which include may priceless pieces of Barbadian History and heritage. This system provides for hard drive storage of security video footage for up to three weeks.

Fire and Burglar intrusion systems were also installed on the compound in order to facilitate additional security of the collections.

Block B

The BMHS temporarily stores at Block B 95% of its collection which consists of approximately 8,000 works of fine art, decorative objects, textiles and furniture. These works are stored in three rooms located on the second level of the building.

The roof of the building sustained damage in 2010 by Hurricane Tomas and is still in dire need of repair and the BMHS is working toward the resolution of this challenge.




During the reporting period, the area that houses the paintings and the furniture, which is mainly used by the conservators and Museum staff, was industrially cleaned as an impact assessment deemed the building to be environmentally unsafe given the state of the building. The damaged roof which has been leaking heavily and allows easy access for birds, rodents and the monkeys and this has exacerbated the situation.

Holetown

The physical storage space at Holetown continues to be of concern with large cracks running along the walls around the entire building. The air conditioning was replaced during the year; however the humidity in the building has not improved. The paintings are continually checked for damage and pest activity, however no signs of infestation or damage have been found to date.

The BMHS recommended to the Ministry of Culture, Sports and Youth and the National Gallery of Art that these collections should be removed at the earliest convenience from this storage space to facilitate repairs to the building. In the interim the BMHS is working on replacing the dehumidifier as soon as possible to maintain stable conditions.



To Achieve at Minimum 10% per year Revenue Growth.

The BMHS did not achieve its financial targets for financial year 2013 to 2014.

For the first time since 2010 the Museum has failed to achieve growth in revenue generated from its commercial operations and development funding. Development funding which is comprised of the annual appeal fund, covenants, donations, and sponsorship and fundraising projects continued the decline which started in 2012 – 2013 and recorded a decline of 1.79% over the previous year.



The BMHS has achieved the following targets:

- Participated in active membership of the Barbados World Heritage Committee and provided heritage support for the review of historic properties within the World Heritage Property and its buffer zone as well as historic sites across Barbados as required by the Town and County Planning and Department Office
- Submitted its report as part of the State of Conservation (SOC) document for the periodic reporting to UNESCO on the management of the World Heritage Property.
- Participated in membership of the Intellectual Property Committee providing support for the establishment of a framework for guidance of Barbadians in negotiating the various intellectual property legislation with regard to their rights and responsibilities

BMHS Management, Council and Committees


The BMHS Management Team (Baobab) completed its budget for the year, including adjustments made for the reduced subvention from government for the period. The exercise of updating the job profiles of Museum staff with a view to improving organizational efficiency was also completed in draft for submission to the Museums Council for review and approval.

The team also continued to provide the Council with bi-monthly reporting outlining both operational and financial matters for the period under review in order to inform strategic planning for the organisation. In addition the Team facilitated a number of meetings of the Council and its subcommittees geared toward the development of the organisation which focussed mainly on achieving greater operational efficiency and financial self-sufficiency given the current economic challenges in order to ensure the survival of the organisation and continue its mandate as the guardian of our national heritage.

Externally, as a consequence of receiving a subvention from Central Government the Museum prepares a Management Report for the Ministry of Culture, Sports and Youth on a bi-monthly basis and these reports were completed as scheduled. The BMHS continues to work with the Ministry of Culture, Sports and Youth in order to fulfil the vision of an educated Barbadian populace fully cognisant and appreciative of its history, heritage and culture.

Barbados World Heritage Committee

During the period under review the Barbados Museum was represented on the World Heritage Committee which has oversight of the management of Historic Bridgetown and its Garrison in order to preserve the Outstanding Universal



Value (OUV) of the area and therefore maintain the World Heritage designation of the Property. This support included assistance with regard to the creation of appropriate signage for the Property; providing resource personnel and conducting education workshops on behalf of the Ministry of Tourism, for various tourism related entities; and the Ministry of Culture, Sports and Youth to education professionals, to educate them on safeguarding the property and maximising its potential and representation of Barbados. The BMHS also, alongside of the Chair, Deputy Chair and Ministry of Culture, Sports and Youth representatives attended the meetings of the UNESCO World Heritage Committee to ensure that Barbados was adequately fulfilling its World Heritage commitments and maximising the potential benefits of World Heritage Inscription.


The museum during the period also assisted in the overall editing and writing of the State of Conservation (SOC) report for UNESCO in relation to the implementation of the Management Plan for Historic Bridgetown & its Garrison. This activity is a major component of World Heritage designation and in fact the Management Plan has been utilised as an exemplar by UNESCO for others in the region and beyond to adopt.

In addition, the BMHS provided consultative support for the preparation of the nomination for the Story of Sugar which would see the addition of further sites in Barbados to the World Heritage roster. The BMHS also supplied consultative support in the form of technical expertise in the review of proposals submitted to the Town and Country Development Planning Office for properties within the World Heritage Property or its buffer zone and other sites of historic significance in Barbados. The Shilstone Memorial Library also provided support in the absence of a World Heritage Resource Centre to persons wanting to conduct research of the history of the Property.

Intellectual Property Committee

The BMHS also provided support to the Intellectual Property Committee with regards to developing a Plan for Intellectual Property Education and Awareness as a member of the committee's Culture and Heritage Working Group. This consultation included advising the Barbados Government of Intellectual Property issues as well as assisting with regard to developing public education programming for Barbadians in respect of their intellectual property rights and obligations and responsibilities including but not limited to practices in relation to copyright patents and trademarks.



Auditor's report

1. Incorporation

The Barbados Museum and Historical Society was incorporated under The Barbados Museum and Historical Society Act, 1933. The Society is a non-profit institution. Its mandate is to collect, document and conserve evidence of Barbados' cultural, historical and environmental heritage and to interpret and present this evidence for all sectors of society.

2. Summary of significant accounting policies

a) Statement of compliance

These financial statements have been prepared in accordance with International Financial Reporting Standards ("IFRS") promulgated by the International Accounting Standards Board.

b) Inventories

Inventories are stated at the lower of cost and net realisable value and are valued on the first-in, first-out basis.

c) Depreciation

Depreciation has been provided for on fixed assets on a straight-line basis at rates estimated to write off the cost of these assets, less their estimated residual value, over their expected useful lives. The rates used are:-

Equipment – 20% Furniture and fittings – 10%

d) Subscription income

Subscription income is accounted for on the basis of subscriptions received with no recognition being taken of subscriptions receivable.

e) Currency

These financial statements are expressed in Barbados dollars.


f) Investments
